Permitted Business: All property and casualty lines; health and benefit lines, and other lines upon approval of the insurance commissioner.

Direct Insurance Permitted: All permitted business.

Reinsurance Permitted: Most lines of insurance, upon approval of the insurance commissioner.

Pure Captive	\$250,000
Group Captive	\$500,000
Risk Retentions Group	\$500,000
Agency Captive	\$500,000
Protected Cell Captive	\$500,000
Reciprocals	\$500,000
Pure or Group Reinsurers	One half of the above-indicated amounts.
