REGULATORY ISSUES

Acceptable Insurance Subsidiaries	Agency captives, alien captive insurers, branch, association, pure/single parent, rental, sponsored/series LLC, protected cell, and risk retention group.
Acceptable Corporate Forms	Stock, mutual, reciprocal, nonprofit, or limited liability company.
Permitted Business	A captive insurer shall not directly provide personal motor vehicle or homeowners' insurance coverage, or any part thereof, shall not accept or cede reinsurance, may provide workers' compensation insurance provided pursuant to a program of self-funded insurance of its parent and affiliated companies if: (1) the parent or affiliated company which is providing the self-funded insurance is certified by the commissioner, or (2) the program of self-funded insurance is otherwise qualified pursuant to, if being written in the state, or in compliance with, the laws of the state in which the insurance is transacted.
Direct Insurance Permitted	All permitted business.
Reinsurance Permitted	A captive may provide reinsurance on risks ceded by any other insurer.
