Marsh Market Information Manage Your Insurer Counterparty Risk

Marsh Market Information (MMI) is a one-stop tool that provides access to detailed financial information, ratings, news, and analysis to help clients evaluate the market security risks of their insurance programs — saving valuable time and concern.

Portfolio Summary

The portfolio summary page summarizes the insurers in your portfolio, including ratings, policyholders' surplus, and news. From this page, the user may navigate to view more detailed information.

RATING CHANGES -

The MMI home page displays insurers in your portfolio and provides access to analysis and background documents. On the portfolio summary page, arrows will appear next to a rating if either the rating or an outlook has changed within the past 18 months. Users can click on the arrows to access details about that change.

FAVORITE INSURERS

Users may designate select insurers as favorites and use the sorting tool to have those insurers appear first on the portfolio page. Favorites are indicated by a gold star.

INDUSTRY ANALYTICS

Lists reports, usually created by Marsh analysts, about the insurance industry and various industry segments.

EXCLUSIVE ANALYTICS

An interactive component that allows you to create unique bubble charts, pie graphs, and comparative reports for the insurers listed in your portfolio.


Manage Portfolio

SEARCH FOR INSURERS

You can search for insurers to add to your portfolio by insurer name, insurer group, common name, Marsh Market ID, or country.

FINANCIAL HIGHLIGHTS


Displays specific balance sheet, income statement, premium volume data, and related ratios for the indicated time periods.

Pool Overview

In an intercompany pool each member of the pool writes a certain amount of direct business and cedes it to the lead member of the pool. The lead member buys external reinsurance and retrocedes a predetermined percentage of the retained risk to each member of the pool. The predetermined participation percentages are indicated on the pool overview page. In this manner, any claim related to an insurance policy issued by any member of the pool is reinsured by the lead member.





What are the key benefits of the MMI website?

The website is a one-stop tool for global insurer and industry credit analysis, providing easy access to information that will help you evaluate the market security risks of your insurance program, saving you valuable time and concern. MMI tracks more than 3,500 insurance companies worldwide and:

- Provides ratings and outlooks from all four major credit rating agencies:
 A.M. Best, Standard and Poor's, Moody's, and Fitch.
- Integrates pools, affiliates, and parent companies to allow for deeper "organizational" analysis.
- Offers interactive tools that let you analyze your program's overall credit exposure.
- Provides breaking news for insurers listed in your portfolio.
- Additionally, users have the ability to generate customized reports and alerts about the credit quality of current and

prospective insurers. For example, users can set up email alerts that will let them know when an insurer rating changes, a new Marsh insurer financial analysis becomes available, and/or when there is breaking news.

In the case of mergers, it may be necessary to add the acquiring company to your insurance portfolio. Please contact your Marsh client executive, account representative, or the Market Information Group for assistance.
